Introduction

Welcome to the new Bank to You® portal, moving our established product online to give you greater control over your services, delegate activities to the right staff and do this more quickly and efficiently. This portal has been jointly created by us and our partners at G4S Cash Solutions who carry out your collections and deliveries.

This document is provided to help you get started using the Bank to You® portal and give you pointers on how to carry out important activities.

Whether you're new to the Bank to You® product or already an established customer, you'll see some real benefits from using the portal:

- The ability for you and your staff to monitor, book, change, suspend or cancel individual services with G4S without calling or filling out forms
- Instead of all day bookings, you'll now be able to choose morning or afternoon slots (where available) and have a shorter time window in which you know G4S are due to arrive
- Enables you to control who can carry out different service administration activities, allowing you to delegate to your staff if you want to
- Order funds for your sites easily, either regularly or as required.
- Set up limits for your sites individually for cash orders
- Register new sites and track their progress being approved for services
- Optional email notifications of important events such as new bookings or user changes
- Review and update contact information for your site-based staff so we have up-to-date details if we need to contact you about your services

Terminology

These are some important terms that are used in this document. Please refer back to this section if you need these explained as you use the guide.

G4S	Our partner organisation for Bank to You® who supports the portal and provides the collection and delivery services.
Sites	Your addresses where we carry out services, also known as outlets or branches.
Bookings	This is a collection service booked for a specific site, date and time period. Bookings may be one-offs (just for one date) or recurring (meaning they're set to repeat every 1, 2 or 4 weeks). They can be collection only or can include a delivery of cash if this service is in your agreement with us.
Administrator	A person who has access to the portal and also has full access to its features including the ability to manage sites and other users.
Site User	A person who has access to view and/or place bookings for one or more sites. This role is usually aimed at site-based staff who just need to manage bookings for their location.
Site Contact	A person whose contact details are held on the portal but who does not have a login to access it.

Getting Started

Depending on whether you're an established customer (who has been using the Bank to You® service previously) or a customer who is new to the service, there are slightly different steps to get you up and running on the portal.

Therefore, we have written specific sections in this documents tailored to both categories - please read the following section that is applicable to you.

Getting Started for New Customers

This section will give you an overview of what to expect when you're set up for the Bank to You® service as a new customer.

- When you registered for the service, you'll have completed the Bank to You® application form and an Outlet form for each of your sites. We will use this information to set up your account on the portal, your login and your site addresses.
- As soon as we register your details, you'll be sent a welcome email with a link that can be used to set up your password. The process for this is detailed in the section called *Creating Your Password and Logging In*.
- Once logged in you'll see the Overview page which gives a broad view of what is going on with your account – more detail on this page can be found in the section called *Overview Page*.
- Your first activity on logging in for the first time should be to check that your sites look correct and let us know if anything needs amending. Contact details for us can be found on the portal and in the *Contact Us* section at the end of this guide.
- You'll need to complete a risk questionnaire for each of your sites. This will allow G4S to assess each location for security to make sure that cash services can be carried out safely. Instructions on how to do this can be found in the *Adding a New Site* section of this document.
- You can also set up other users who you want to be able to see or manage information via the portal. This can be either an administrator or a site user with limited access to one or more of your sites. See the *Managing User* section for more details on this.
- Once your sites are approved, you'll be able to book your collections and deliveries (if applicable) that best suit you, subject to availability. This is covered in the *Bookings* section.
- Your portal Customer Number will be displayed at the top of the page whenever you log into the system to help us identify you if you contact us.

Getting Started for Existing Customers

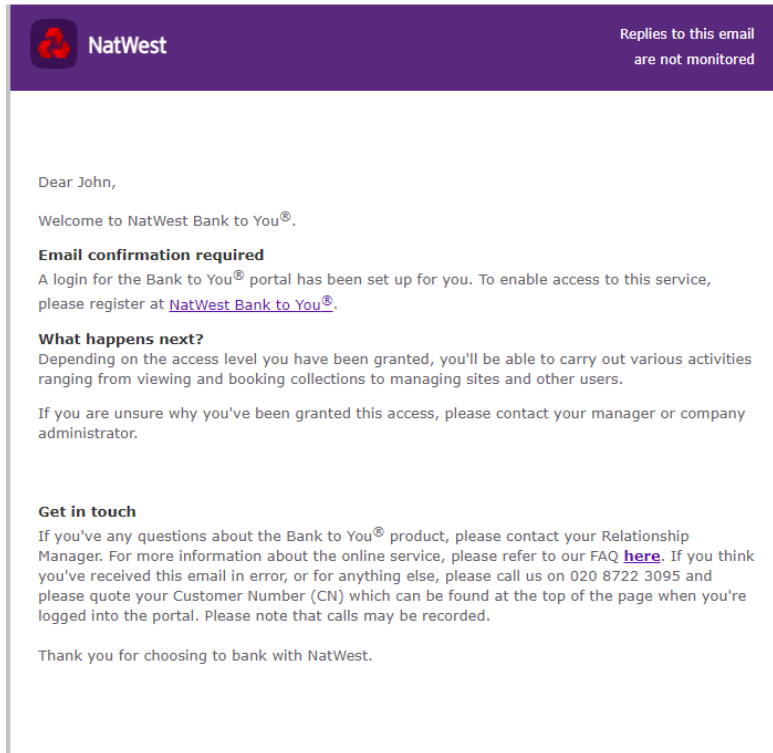
As an established customer, we will transfer your details, including your sites and existing booked services onto the portal for you. As such, this section describes how this will work and what to expect:

- Firstly, we will set up a login for you as the primary representative for your account.
- As soon as we register your details, you'll be sent a welcome email with a link that can be used to set up your password. The process for this is detailed in the section called *Creating Your Password and Logging In*.
- Once logged in you'll see the Overview page which gives a broad view of what is going on with your account – more detail on this page can be found in the section called *Overview Page*.
- Don't worry if you don't see your sites or bookings listed straight away - G4S will be transferring your information over and will let you know via email when it's ready for you to review.
- Once you're happy that your sites and bookings have been moved over, your services will switch over transparently from the start date we have advised you.
- You can also set up other users that you want to be able to see or manage information via the portal. This can be either an administrator or a site user with limited access to one or more of your sites. See the *Managing User* section for more details on this.
- Please note that as part of moving to the new system you'll be given a new Customer Number to replace your old Contract Number. This is displayed at the top of the page whenever you log into the system.

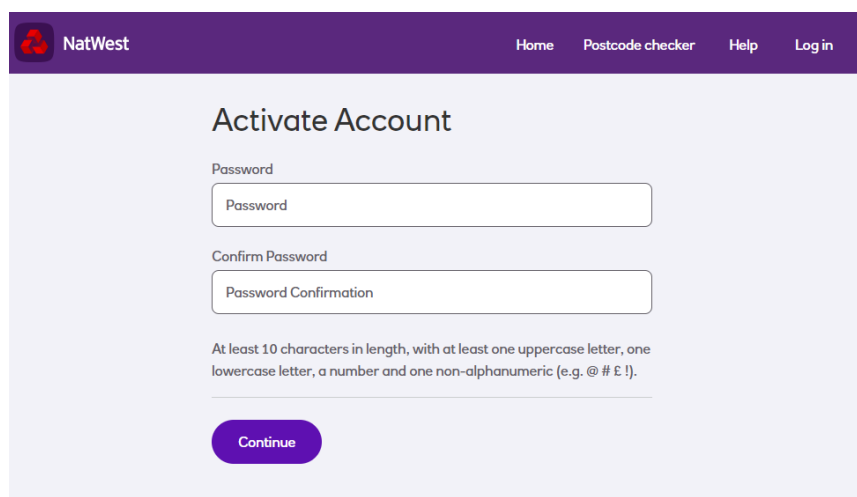
Creating Your Password and Logging In

When G4S first create your account you'll receive an activation email as follows:



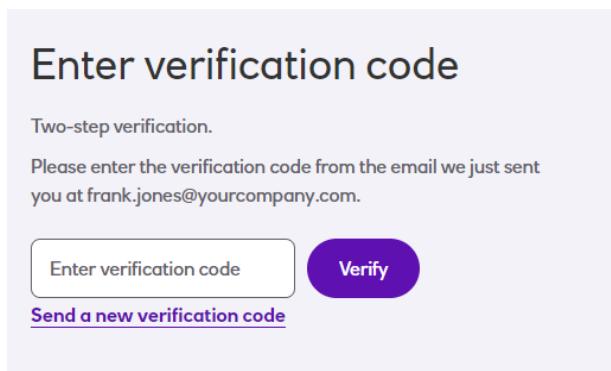
Select the link to display your initial password creation page. You've 5 days from receipt of the email to do this, after which it will expire. If this happens, you'll need to contact us to request a new one (see the *Contact Us* section at the end of this guide).

When creating your password, please note the minimum requirements for it to be secure:

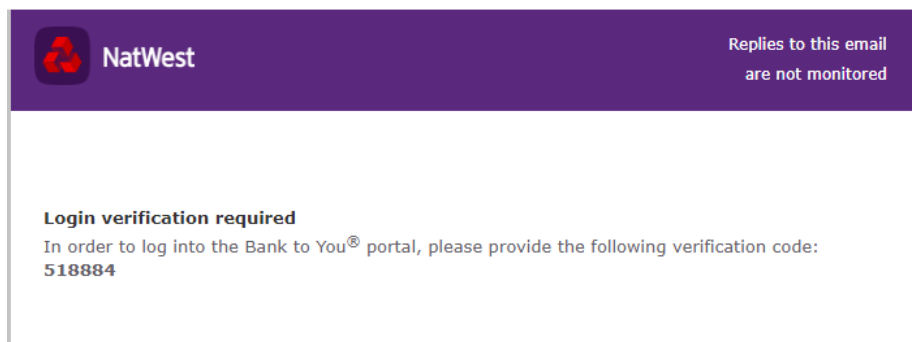

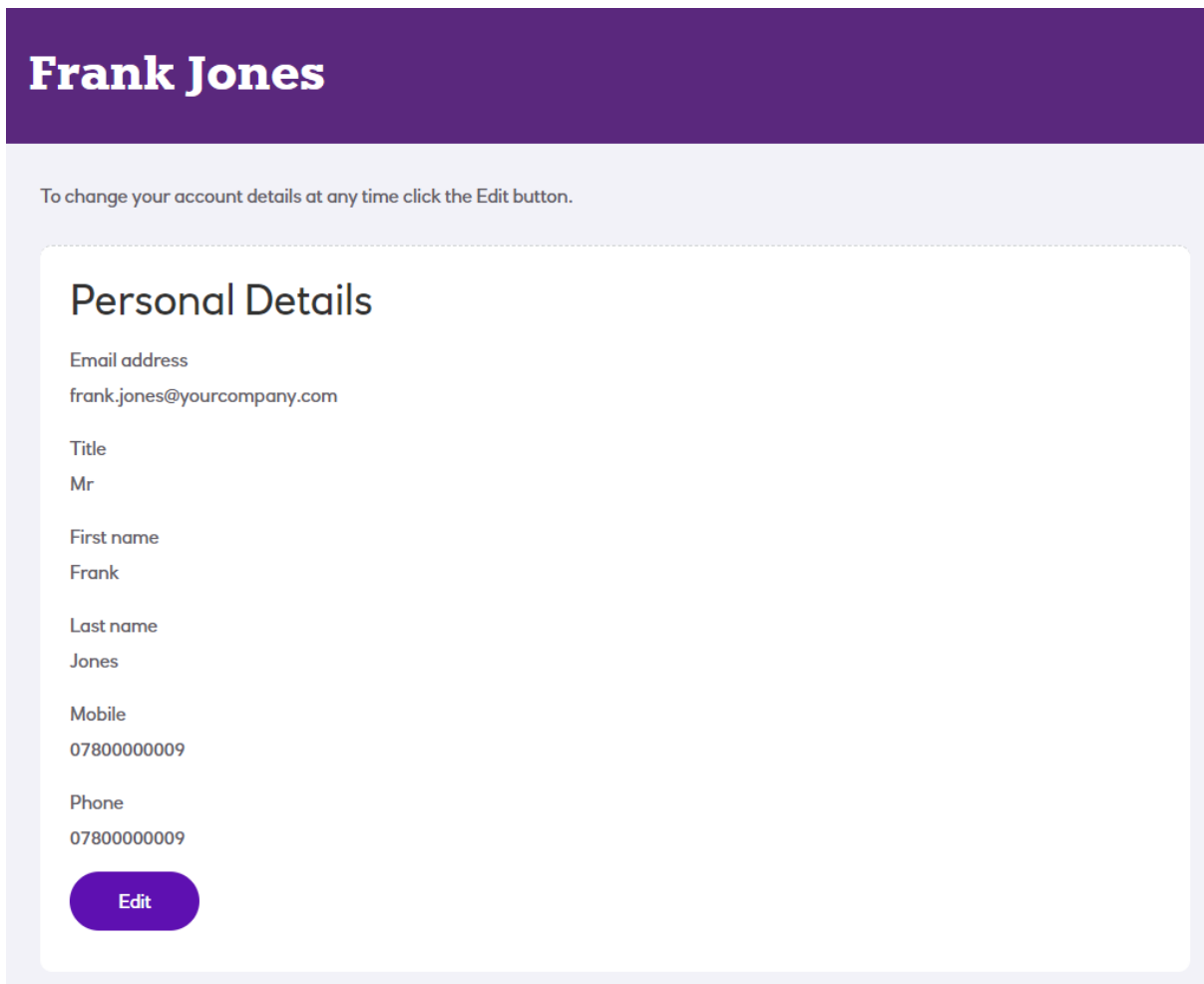
Updating Your Contact Details

At any stage you can update your user profile details by following these steps.

First, select *Users* from the top menu, the *My profile*:



You'll then see the following screen where you can view your user profile details:



In order to change any of the details, click the **Edit** button. There are some rules to be aware of about this information:

- All fields are mandatory except for *Mobile*. However, you may input your mobile number into the *Phone* field if you don't have a landline number.

- Changing your email address is a special case as it is also your login. See the following section for more details.

Changing Your Email Address

Refer to the section immediately above for information how to access the *Manage Profile* page. From here you can change your email address by clicking the **Edit** button.

Because your email address is also your login, changing this will cause you to be automatically logged out for security reasons.

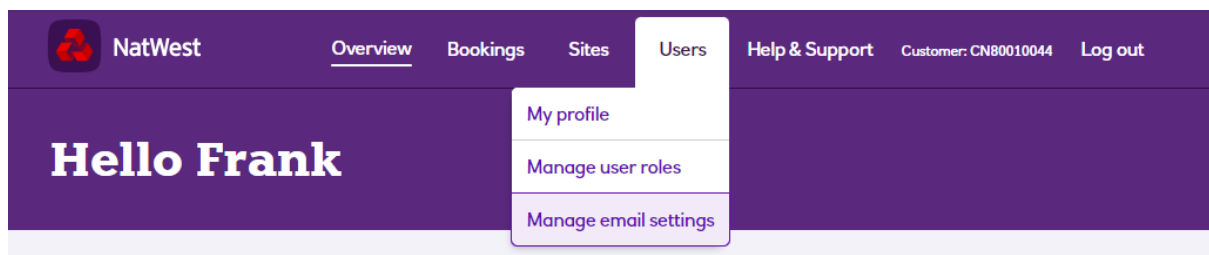
Please note that you cannot have the same email address as another user set up against your company.

It is important to take care to ensure your email address is accurate. Click the **Save** button once you've completed the change.

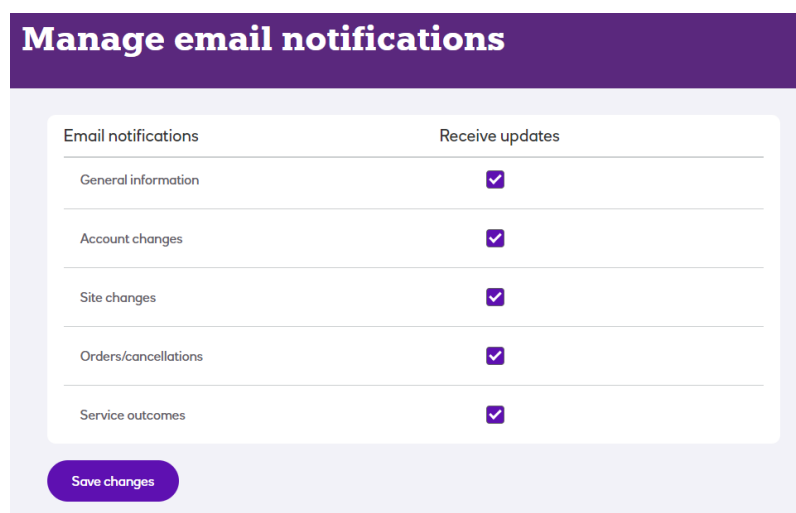
Changing Your Email Preferences

As an administrator, by default you'll be sent email notifications whenever an important activity takes place. This includes creating or amending sites, users and bookings. However, if this is not useful to you, it is possible to update your preferences to switch this off.

Firstly, select the *Manage email settings* option under *User Profile* on the menu:

On most pages of the portal, there will be a menu bar available at the top as a quick way to navigate to key information and functions you may need to use.

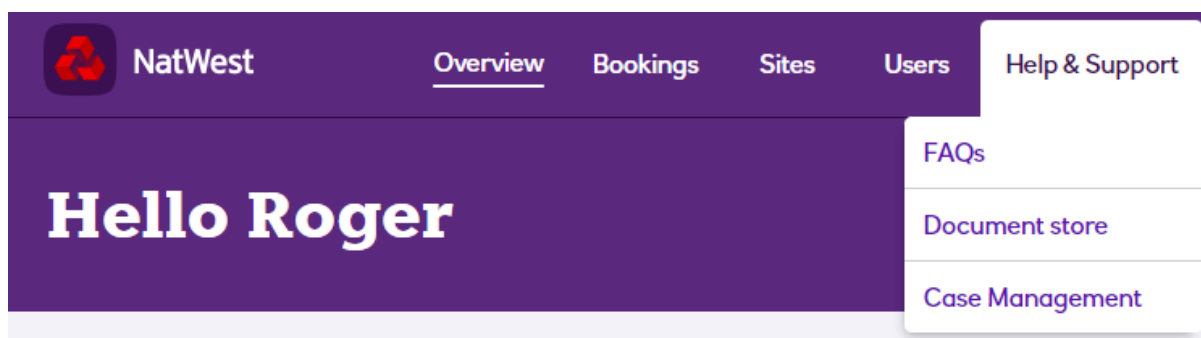


A summary of these headings are:

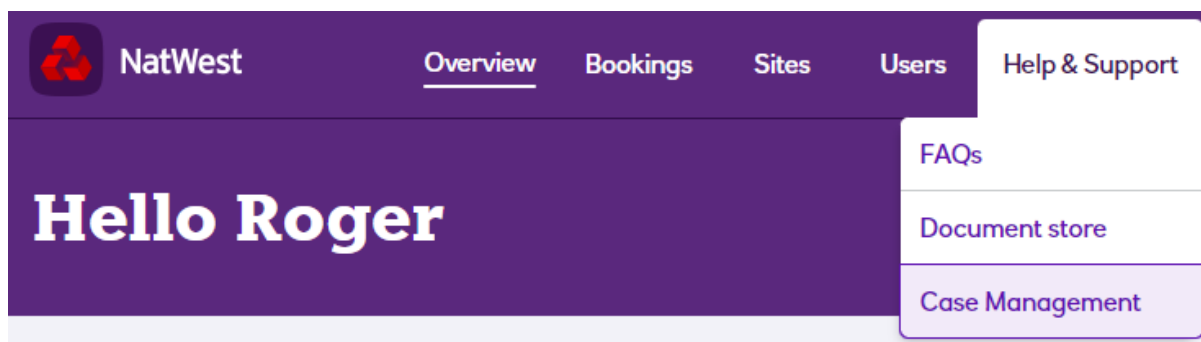

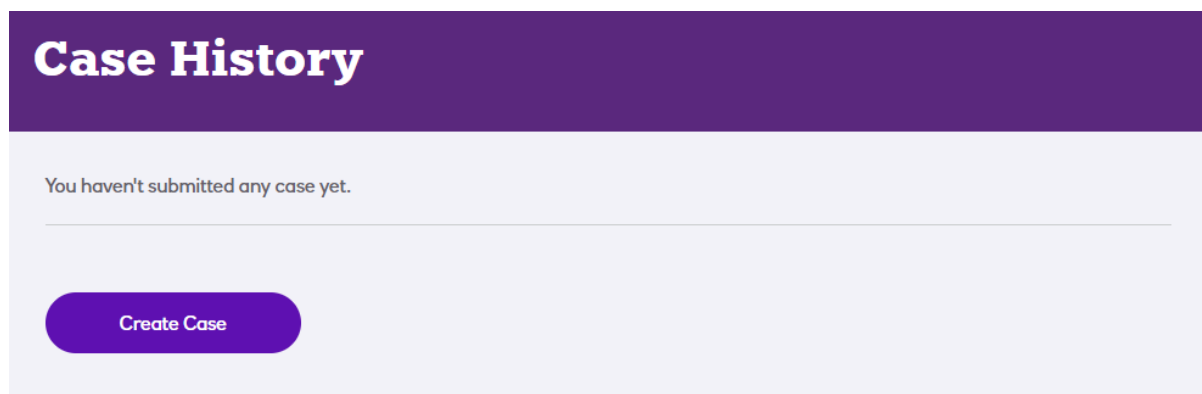

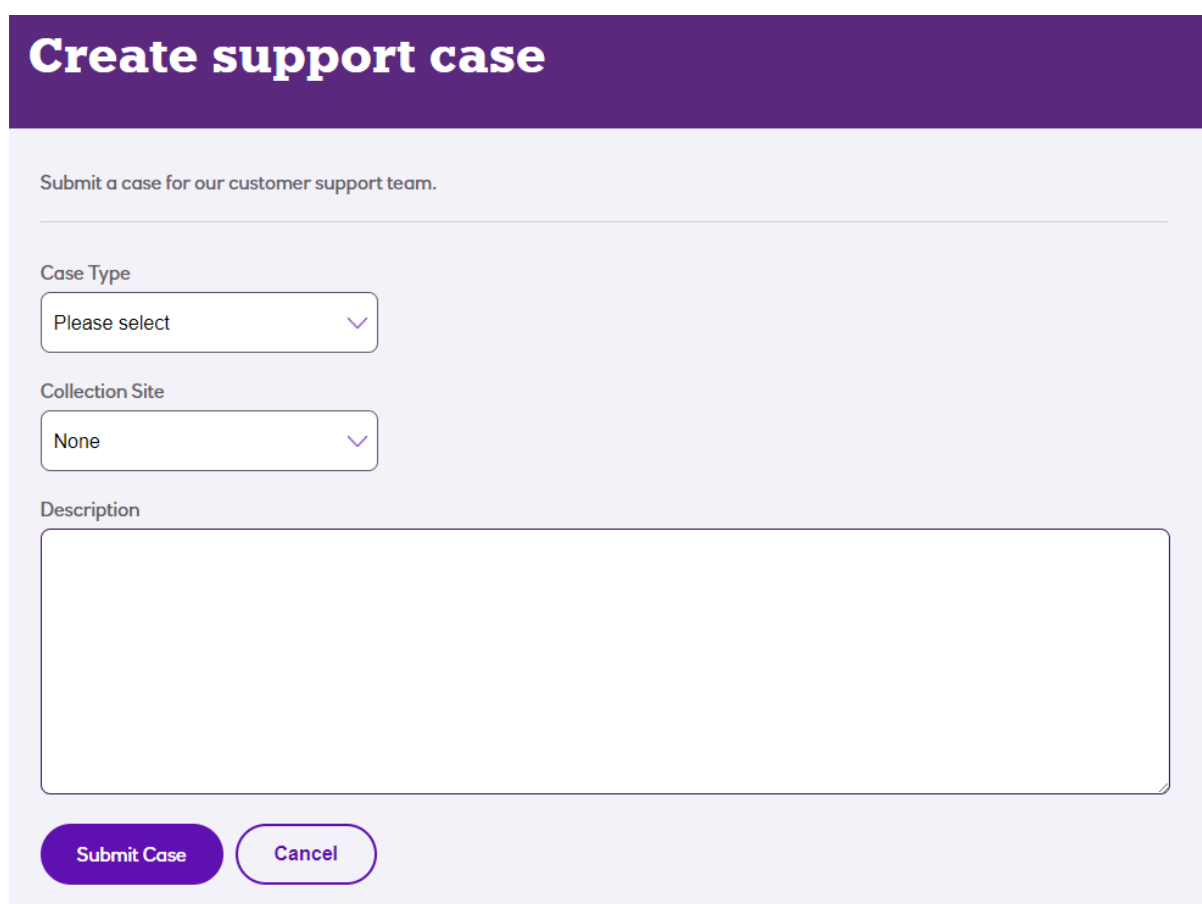

The **Case Type** will give you a list of topics to choose from – select the one that best matches your query. Depending on which one you choose, you may see some text appear underneath to give you guidance which may address your question or direct you on next steps.

If your query relates to a specific site, please choose that site from the **Collection Site** drop down list.

Finally, the **Description** text box allows you to type details of your query. Generally, the more detail you can provide, the better. Once complete, click the **Submit Case** button and you'll get a confirmation via email and you'll be able to see your new case listed:

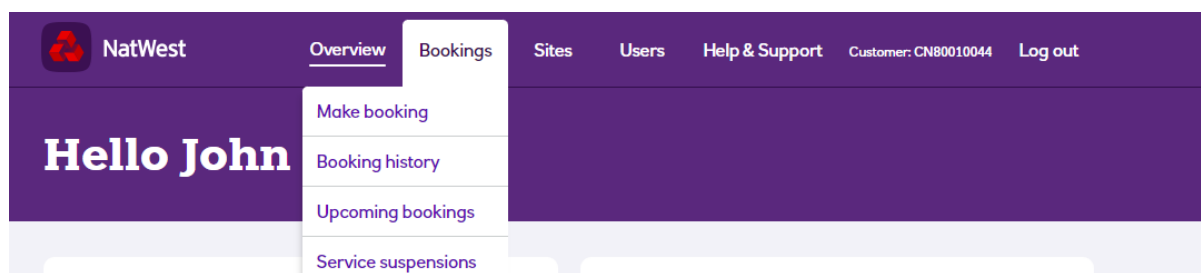

When any updates are made to your case, you'll be sent an email to advise you to log in and review the changes. Once you confirm your query been dealt with, it status will be changed to *Closed*.

Managing Bookings

The **Bookings** menu contains functions relating to making and managing bookings for both collections and deliveries.



In general, these are available to all users that have been granted access to view (or manage bookings) for one or more sites.

Cut-off Times

Before making bookings, it is important to understand there are certain deadlines for requesting new services or changing existing ones.

To allow for G4S to plan and prepare for your services, we have set cut-off times for new bookings, amendments and cancellations. More notice is required for changes to services with deliveries as this includes time to prepare your cash order and transport it ready for delivery.

The portal will always ensure that you're creating or changing bookings in time, but this table is a useful reference to know what these are:

A key to the calendar is as follows:

The **Recurrence** setting determines if you want a one-off service that happens for one date only or a regular, repeating service.

This example is for a customer that has delivery services enabled. If you're a customer that currently does not have this option, the *Delivery* column heading and data will be blank.

The default display is by date order with the earliest one first irrespective of site – you'll only be able to see bookings for sites that you've been set up to have access to.

There are filters you can apply for **Order placed by** or **Site name**. There is also a tick box to allow you to display or hide cancelled bookings. This is useful if you've made a lot of

changes to your future bookings and have a number of cancelled dates that you don't need to see.

The default **Upcoming** view (as above) displays individual booked dates whether they're one-off bookings or dates added as a result of a recurring booking. Changing the Collection Value Level

When booking a collection, you'll have selected whether you require a £7.5k service or a £15k service. However, if you want to change this at a later point, it is possible to upgrade or downgrade the value chosen. Cancelling a Recurring Booking

To cancel a recurring booking, the process is the same as above for changing the end date except that you would select the **Cancel** button instead of using the **Change end date** field. This automatically chooses today's date as the end date for the recurring booking so you don't need to select it from a calendar. Otherwise, it behaves in exactly the same way.

Deliveries

Please note that these functions will only be available if:

- you've deliveries as part of your service,

Note: if you do not see the section shown above where you can choose delivery amounts, this could be for a number of reasons:

- It may be that the site you are trying to book for hasn't been allocated a drawing limit – see the section on *Changing a Site Drawing Limit*.
- Alternatively, it could be that you haven't been granted the ability to place orders. This can be updated by an Administrator referring to the *Managing Users* section.
- It is past the cut-off for booking a delivery for the date selected – see the section on *Cut-off Times*.

Cash ordered for delivery is provided in packs: 5 different coin packs and 1 type of note pack.

Some points to note before selecting the packs you require:

- The available limit is based on the lower of either the site drawing limit or the unused part of the customer account limit for that day (noting that other sites may have already placed delivery orders for the same date).
- The coin and note packs displayed are of set values and denominational breakdowns.
- A site can order a maximum of two coin packs and as many note packs as required up to the available limit.

Using the +/- icons, select the desired number of packs within the above rules. As each is selected a running total will be displayed underneath:

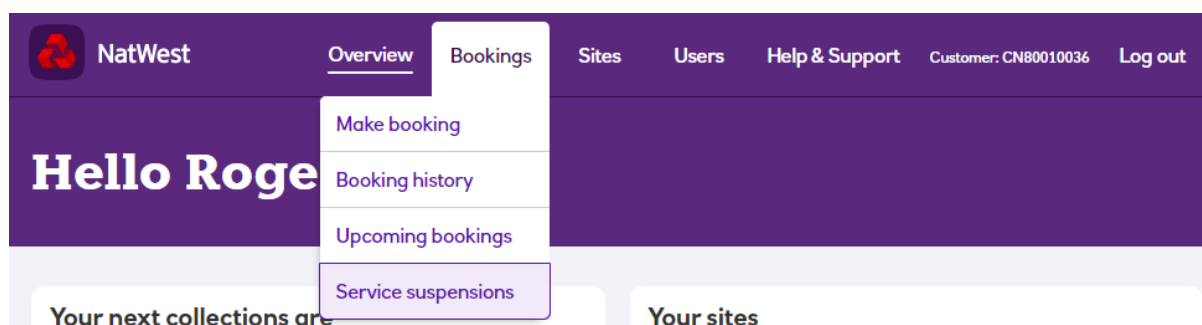
Service Suspensions

This option enables you to suspend services for one or more sites for a set period – for example if a site is closing for refurbishment or holidays.

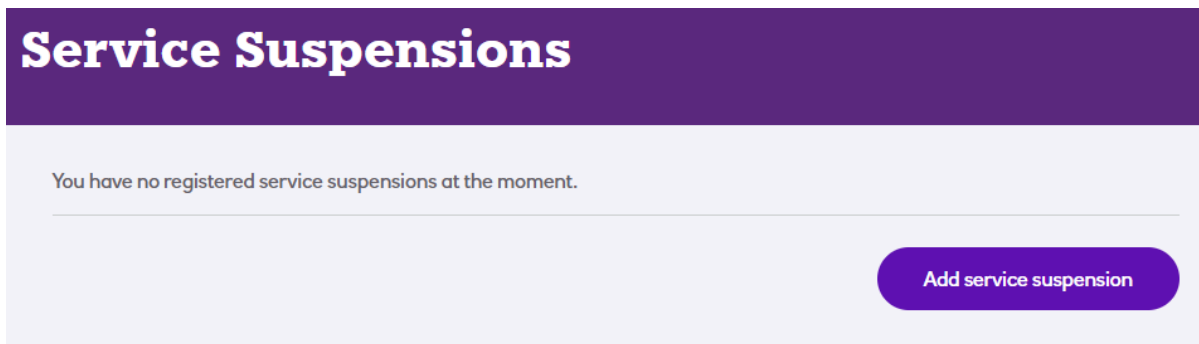
Suspensions work in the following way:

- Once set up, a suspension will cancel any booked services that fall within the selected date range (both collections and any associated deliveries where applicable).
- A suspension will not cancel any orders that have already passed their deadline for cancellation. Please refer to the *Cut-Off Times* section at the beginning of *Manage Bookings* for specific rules regarding cancellations.
- Whilst a service suspension is in place, sites included in it will not be able to place bookings for dates during the duration of the suspension.
- A suspension will not remove any ongoing recurring bookings, only cancel the dates that relate to the period of the suspension. Such recurring bookings will continue to generate bookings for dates after the suspension period expires.
- Once a suspension has been created, removing it will not automatically rebook any cancelled services within that date range. If you need to recreate these bookings, we recommend you create these as one-off services using the standard booking methods covered in this *Managing Bookings* section. Please note, although you can create a recurring order to cover the gap created by a removed suspension, care must be taken if you already have a recurring booking that will automatically resume after the suspension ended.

In order to create a suspension, navigate to *Bookings/Service Suspensions* from the menu:



This will display a page listing any pre-existing suspensions:



To create a new service suspension, click the **Add service suspension** button to display the following form:

Use the left-hand pane to select a site for the suspension period and then use the **Add To Suspend >** button to move it into the right hand pane – repeat for as many sites as will be affected by the suspension period. You can use the **< Remove** button to return any sites selected in error.

Handy tip: you can click a site, hold the mouse down and drag the pointer to select more than one site at once.

Once done use the **Choose start and end date** fields to set the suspension period (noting the text guiding you through the rules underneath).

Once done, click the **Confirm dates** button to continue – this will display more information about the action before it is committed:

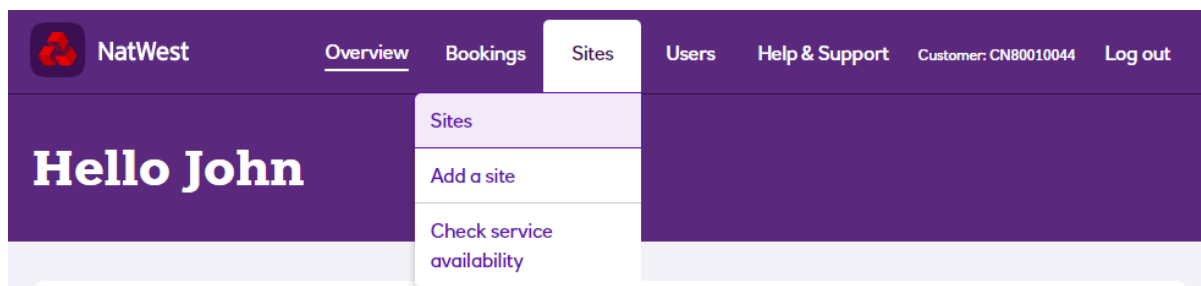

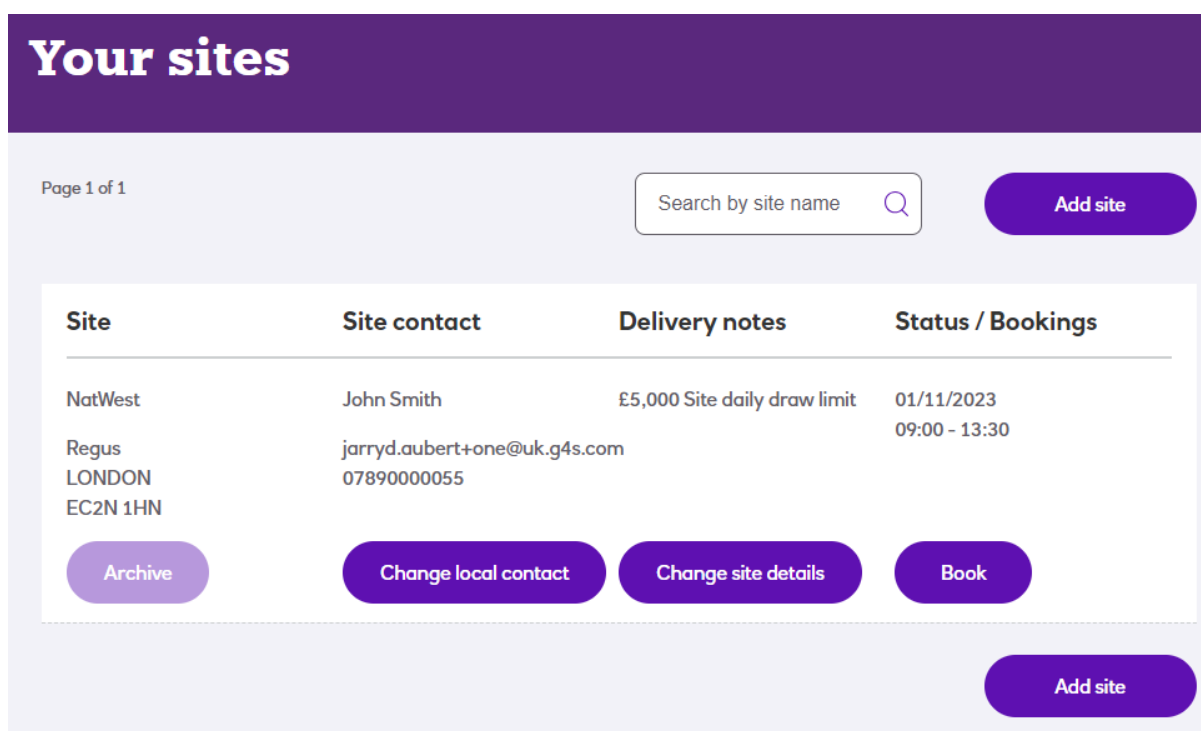

Managing Sites

To view and manage your sites, select *Sites* from the menu:



This will open a page that displays all your sites along with various options and their current status:



This example above is for a customer that has deliveries enabled. If you're a customer that does not currently have deliveries as part of their service then the text under the **Delivery notes** column will indicate "Deliveries not enabled" for all sites.

The **Status/Bookings column** will show the next service for this site (where applicable). It will also show any pertinent information about the approval status of your site – this is because all new sites must go through an approval process which is described in the next section, *Adding a New Site*.

The following buttons are under each site listed and these do the following:

- The **Archive** button will allow you to remove a site from the list but only if it has no future bookings. Any such bookings will need to be cancelled first, otherwise this button will be disabled. Once archived, the site will show on this page for 7 days before being filtered from view.
- **Change local contact** will allow you to set a different person as the **Site contact** for this site from the list of users you have. This setting will not affect the users who've access to this site.
- **Change site details:**
 - This allows you to change the name of your site as it is shown on any pages or lists on this site or in emails. You cannot change the address of a site as this could invalidate any approvals granted to the site. You'll need to contact us in this instance or create the site again.
 - If your account has deliveries enabled and you're an administrator, then this option will also allow you to set or amend the drawing limit for this site. This determines the maximum limit this specific site is allowed to order on any one day, subject to the overall account drawing limit available.
- The **Book** button is a quick method to start the place booking process with the site already selected – see the *Managing Booking* sections.

Adding a New Site

This sections covers the process of creating a site for customer with or without deliveries. There are some small differences which are highlighted at the relevant points.

Before starting the process, please note that you'll need to have the following information to hand:

- The full and correct address of your site
- A preferred short name for the site will make it easy to identify when listed anywhere on the portal
- The name and contact details for the person who will be the primary contact for that site (a list will be shown of existing contacts to choose from or you can add a new one)
- Information about the expected collection and delivery values and volumes expected for this site as well as the initial drawing limit (deliveries customers only)
- As much information about the physical premises as possible, required to answer a list of questions to allow us to assess the security of the location.

Once ready, navigate to the *Sites* page and select the **Add site** button to start the process. The first page gives important information about creating a new site for the portal:

These pages will take you through the site registration process.

You will need to know the full address, who you wish to be your primary contact and details of the number and volume of services you'll require. You'll also be asked to complete a risk assessment questionnaire which requires a good local knowledge of the site.

Once you complete this application, the site will need to go through an approval process with the bank and G4S and if accepted, you'll then be able to make bookings for it. We'll keep you informed of progress via email.

Only use this process to add an additional site if the funds are to be credited to the bank account currently registered with Bank to You.

If another bank account is to be used please contact your Relationship Manager or normal bank contact to complete a new application form.

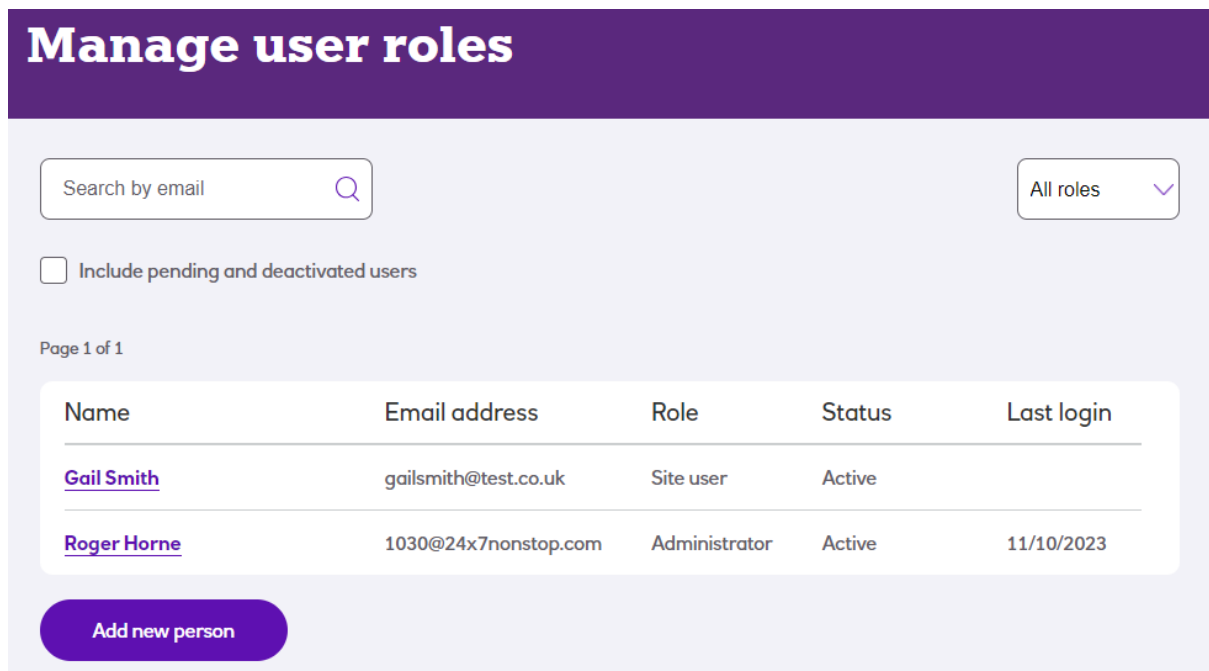

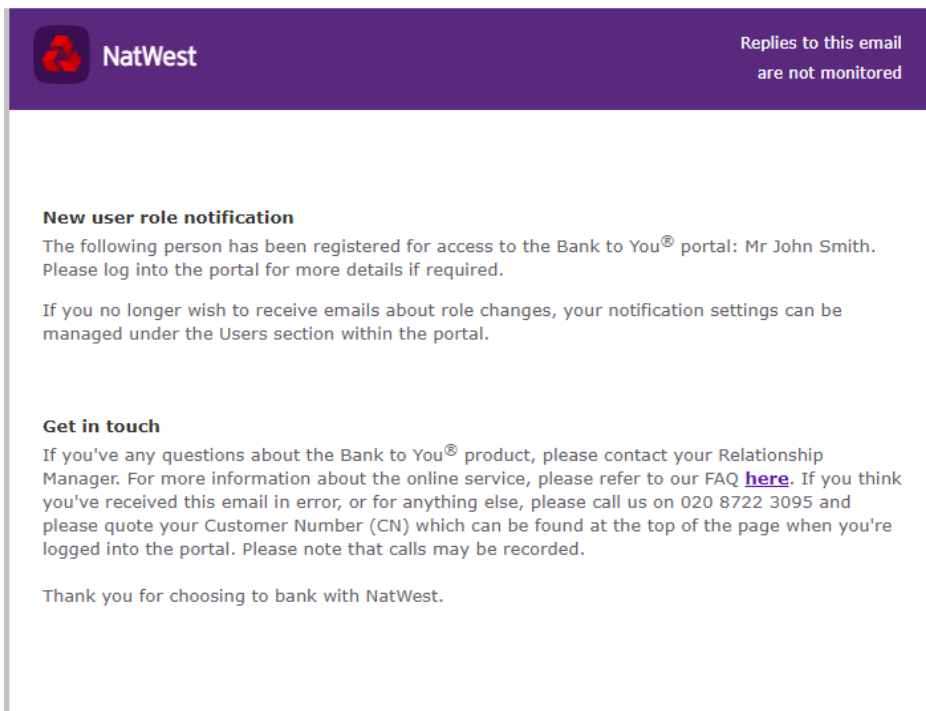
The columns are as follows:

- View only** The user will be able to see the bookings for this site but not create, amend or cancel them.
- View and edit** As above but the user can create, amend and cancel bookings.
- Book deliveries** Applicable to delivery customers only, this indicates if the user is able to place orders for funds to be delivered as well as change or remove deliveries.

If there is a site that you don't want this user to be able to see, make sure all columns are unticked.

If your account does not have the deliveries facility, you'll not have access to the Book deliveries column.

Once done click the Save button to apply the changes. This will generate an email to confirm that the user has been created:



If the user is not a contact only, they'll also receive a welcome email containing a link to follow to set up a password. This process is covered in the section *Creating Your Password and Logging In*.

Changing User Details or Access Level

Firstly, navigate to the user you wish to amend as shown in the *View User* section above. You'll then be able to edit their details. Please refer to the above section *Adding New Contact/User* for guidance on how to update this form.

Two important points to note are:

- For security reasons, the first user of the system is treated slightly differently and only that person can view and change their own details. If this person is not available and you need to amend their login in some way, please contact us (see below).
